Even if you have chosen the Website Version, you reserve the right at any time by giving reasonable notice in writing to the Hong Kong branch share registrar, Tricor Investor Services Limited, to change your choice.

Please mark a "√" in the appropriate box on the enclosed reply form ("Reply Form") and sign and return it by post or by hand to the Hong Kong branch share registrar, Tricor Investor Services Limited at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong on or before 13 April 2023. If you post your Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp.

If the Company does not receive a duly completed and signed Reply Form from you (or another response from you indicating that you object to receiving the Website Version of Corporate Communications) on or before 13 April 2023, you will be deemed, until you inform the Company otherwise by reasonable notice in writing at the office of the Hong Kong branch share registrar at the above address or by email to is-qhhl-ecom@hk.tricorglobal.com, to have elected to receive all future Corporate Communications by Website Version instead of receiving them in printed form. In that event, when the Company makes a Corporate Communication, it will only send you a notification that the Corporate Communication has been made available on the Company's website. The notification will be sent to you by email or by post at your address as it appears in the Company's register of members maintained by the Hong Kong branch share registrar.

You may at any time by reasonable notice in writing to the Hong Kong branch share registrar at the above address or by email to is-qhhlecom@hk.tricorglobal.com to change your choice of means of receipts of the Corporate Communications. If you have elected (or are deemed to have elected) to receive Corporate Communications by Website Version and for any reason have difficulty in obtaining access to Corporate Communications on the Company's website, the Company or the Hong Kong branch share registrar will upon request send the relevant Corporate Communications to you in printed form free of charge.
